#### **RECORD OF DECISIONS OF THE PLENARY**

### **Opening Session of the Plenary**

1. The Conference was formally opened on Tuesday morning 25 February 2020 by Dato Jana Santhiran Muniayan, the Deputy Secretary-General, Ministry of Transport of Malaysia.

### **Election of the President**

2. The Conference unanimously elected, by acclamation, Datuk Isham Ishak, the Secretary-General of the Ministry of Transport of Malaysia, as President of the Conference.

- 9. The Conference elected, by acclamation, Mr. Øyvind Hernes (Norway), as Chair of the Drafting Committee.
- 10. The Conference referred the consideration of the draft Convention on the International Organization for Marine Aids to Navigation (agenda item 6) and associated draft Conference resolutions (agenda item 7) as well as documents which had been submitted under these agenda items, to the Committee of the Whole for detailed consideration, requesting it to report to the Plenary on Friday, 28 February 2020, at 9.30 a.m.
- 11. The Conference then adjourned until Friday, 28 February 2020, at 9.30 a.m.
